# 4. Matters arising and action points:

Jilly Green, who is looking into recruiting more Community Councillors, asked Chris Campbell for further advice on legalities.

## 7. **Elected Member report:**

Peter Henderson told the CC about the upgrade to the mast for Pinwherry at Little Pinmore Farm, this should improve the rural connectivity.

Muck Road is due to be resurfaced at the end of the month.

ARA have been out to inspect and there is no gully block at Quiet Waters. Bob Green advised Peter that the works were due to be carried out in eleven days, and no one along Muck Road has had any formal notifications. There are a number of business trading along Muck Road, and this will be of some concern to them as will affect their trading, should the road be closed to residents. Peter Henderson has a meeting with ARA and will put forward PPCC concerns and then update.

Joy Chamberlain, said there had been a road closure in Barrhill for resurfacing works the ARA website had said that the closure was in effect 8am-3.30pm when actually it was until 5.30pm, she had to wait for 2 hours in order to get her dog to the kennels at the other side of Barrhill. Joy went on to explain there had been no notifications on any signage up to Barrhill regarding the times of the closure, then incorrect information on the ARA website. Peter Henderson advised he would put this forward in his meeting the next day with ARA.

Peter said that anyone in the area receiving Council benefits will receive a Scotland loves local pre paid card, which will enable people to buy essentials.

There is to be a VASA funded leaflet delivered to every home in SA with important contact details for emergencies for example Police, Fire, Electric Board etc.
