- Advised that the Budget position, in an extremely challenging climate was due to be set w/e 1st March. Confirmed that SAC was unlikely to opt for a tourist tax, had made good progress in the move to the use of electric vehicles, would be restarting Rural Panels. Additionally echoed the words of CC in the importance of CC's to both SAC and the local community.
