**Declarations of Interest:** None

Approval of minutes dated 11th January 2024: Proposed DH. Seconded JG

**Matters arising:** DH informed the meeting that PPCC were currently seeking quotes for the path from the Willowdene bus stop to the car park gate. **Action PPCC** 

DH is investigating prices for signage publicising the Community Centre. He had received a quote of £696. BD will send a link to the site he used for the school sign. AW will do the graphics for an  $800 \times 1500$  sign. Action DH, AW and BD

NG and BD had investigated a WIFI solution for the main hall and would liaise with electrical contractor to run cables. **Action NG and BD** 

BD made a suggestion regarding tables that several of those in attendance had experience of. The Bolero table could accommodate 6 with people on the ends and were very stable. Although no decision was made, it was decided that the maximum number of tables that the hall could hold was 10 and it followed that 60 chairs would be needed. **Action C/F** 

Railings. The points were still to be ground off. BD said that he had delayed the Justice Team from painting them until after the Phase 3 handover as, technically, the playground was a construction site **Action NG and BD** 

BD NG and JW had attended the first progress meeting and Westgale reported that things were progressing satisfactorily. Gordon Fleming had asked that a list of kitchen equipment and furniture be with him in the following 24 hours. Given the timeline BD and NG had obtained a scale plan and submitted a 'wish list' to Gordon.

# Pinwherry and Pinmore Community Development Trust | Project Officer Monthly Report Mid January – Mid February 2024

### Pinwherry School - Phase 3

I haven't received the first interim certificate yet from the architect, nor the first invoice from the contractor, so I can't start the RCGF claims process yet.

### School Insurance

The insurance schedule has been signed by Ann and I have sent it off to the insurers.

## **Core Costs**

This month I have submitted two funding applications for salaries for The Auld School, which has taken up most of my time:

- 1. Community Empowerment Fund. This is a Scottish Government fund, administered by South Ayrshire Council, primarily for capital funding, but they have a very small pot of revenue funding available (£11,900). All projects must be completed by 30<sup>th</sup> November 2024. So, I have applied for 9 months of the salary for the Caretaker (16 hours per week x £13 per hour x 39 weeks (Mar Nov) = £8,112). I'm not too confident we will be successful because of the very limited pot of money available and because It's only over 9 months, so they may not want to fund a salary for that short time frame.
- 2. **Kilgallioch Community Fund**. I have applied for both the Cleaner and Caretaker salaries for two years from 1<sup>st</sup> May 2024 30<sup>th</sup> April 2026. The deadline is 12<sup>th</sup> February for an outcome in April. I have asked for a total of £32,448 at £16,224 per year. This is broken down in to the Cleaner (8 hours per week x £13 per hour x 52 weeks = £5,408) and the Caretaker (16 hours per week x £13 per hour x 52 weeks = £10,816). Because we have recently had £60,000 from Kilgallioch for the school, they may not want to consider another funding application in a short space of time, but I thought it was worth a shot!

I am reviewing funding options for the Community Co-ordinator and will work on that next.

### Pinmore Play Park

I have raised the order for the play park equipment etc with the supplier, so that we can keep the price at the quote we have secured funding for.

They came back to me asking for colour preferences for the MUGA flooring and outside "cage" element. This was put to the Trustees and the colour with the most 'votes' was green, so I have passed that on to the supplier.

## Reporting

I have written and submitted the final grant report form to the D'Oyly Carte Foundation regarding the Pinwherry field horticultural project. Thanks to Brian for sending me photos, which we also sent as evidence. Apart from confirmation of receipt, I haven't heard anything else, so hopefully they are happy with what we have done so far.

I have also received emails from Foundation Scotland asking me to complete yet more reports! However, upon further investigation, it appears I can't actually complete the 3 outstanding reports yet because:

- The report for the 2023 core costs actual contains questions for someone who would have received funding for a training course, so it's obiously an admin error!
- One interim report for Community Development Officer match funding doesn't actually provide any questions for me to fill in

•	There is a final report for the Kilgallioch funding for phase 3 of the primary school works, however because that work is still on-going, I can't report on it yet!I've asked the grants adviser to let me know what she wants me to do, but they must be having technical issues!
